**ORDER**

The C & DSE has reported that many schools in the State are not following the three language Formula in general and not imparting Telugu as one of the three languages as prescribed in the G.O. read above.

2. In the circumstances stated by the Commissioner and Director of school Education, Hyderabad in his letter read above, Government after careful examination of the matter hereby order to make study of Telugu language as compulsory and to follow the “ Three Language Formula” for implementation in all the schools in the State.
3. The Commissioner and Director of School education Andhra Pradesh, Hyderabad shall take further action to implement these orders without fail
4. The following Notification shall be published in the Andhra Pradesh Gazette:

**NOTIFICATION**

In exercise of the powers conferred by Section 7 read with Section 99 of the Andhra Pradesh Education Act, 1982 ( Andhra Pradesh Act 1 of 1982) and in supersession of the existing rules/ proceedings/instructions/orders on the subject, the Governor of Andhra Pradesh hereby makes the following rules relating Three Language Formula.

1. **Short title, application and commencement**
  - (1) These Rules may be called the Andhra Pradesh Study of Languages in School Education Rules, 2003.
  - (2) They shall apply to all the Schools in the State.
  - (3) They shall come into force with effect From the academic year 2003-2004
  
2. **Study of Languages in Schools.**

In pursuance of three language Formula, the students in the schools shall study the Languages from Class I to Class X as specified below:-

  - (1) **Telugu Medium Schools**
    - (a) First Language – Classes 1 to X – Telugu
    - (b) Second Language – Classes VI to X -Hindi
    - © Third Language – Classes V to X – English
  
  - (II) **English Medium Schools :**
    - (a) **First Language**  
Class I to Class X – (i) Telugu in case of the students whose mother tongue is either Telugu or English
  
    - (ii) Telugu or Mother tongue in the case of students whose mother tongue is other than Telugu or English
    - (b) **Second Language**  
Classes VI to X – (i) Hindi in the case of students who have taken Telugu as First Language  
(ii) Telugu in the case of the students who have taken other than Telugu as first Language
    - © **Third Language**  
Classes I to X – English
  
  - (III) **Other Media Schools: (other than Telugu & English Mediums)**
    - (a) **First Language**  
Classes I to X – The language of the Medium of instructions concerned.
    - (b) **Second Language**  
Classes VI to X – Telugu
    - © **Third Language**  
Classes V to X – English
  
3. **Implementation of Three Language Formula**

All the new Schools which are going to be permitted from the academic year 2003-2004 onwards shall follow the “Three Language formulas as is being implemented in the State.
  
4. **Certain prohibition on the Management of the school**

On and from the date of commencement of these rules, no management of the schools shall,

  - (i) Allow any student to study the languages deviation of rule 2;
  - (ii) teach any language in addition to the language prescribed in rule 2.

5. **De-recognition of the Schools** Any management of the school which violates clause (i) of rule 4, shall be De-recognized and permission granted to the school shall withdrawn after giving an opportunity to it.
6. **Ineligibility to hold the post of the Head of the school** Any head of the schools/Institutions, who commits the prohibition specified under Rule 4 shall, after giving an opportunity, be declared as ineligible to hold the post and also further appointment as head of another recognized school/institution and shall also be removed from the post held by him.
7. **Exemptions** It shall be competent for the Commissioner and Director of School Education basing on the report of the School through the District Educational Officer concerned to exempt any student, Whose mother tongue is not Telugu and Who migrates from other State to join in VII Class and above, from studying Telugu as Second Language.
