**ORDER:**

In the reference 1<sup>st</sup> read above, the secretary, APREIS, Hyderabad has stated that the Government have sanctioned 94 KGBV Schools under the Management of APREIS. He has further stated that the students studying in KGBVs are dropout SC, ST, BC and Minority girls. The Government is providing free lodging and boarding in addition to uniforms, bedding, dhobi charges and stipend of Rs.50/- per month. There is already fee exemption for SC, STs. The 10<sup>th</sup> class students of KGBV Schools are not able to pay their examination fee of Rs.125/-. This year 1850 students are going to appear for the ensuring SSC, March, 08. Therefore, he has requested the Government to issue orders for exemption of payment of SSC fee to the students appearing from KGBV Schools.

2. The State Project Director, Rajiv Vidya Mission (SSA), Hyderabad vide his letter 3<sup>rd</sup> read above has stated that there is a provision of exemption from payment of SSC Public Examination Fee to the S.C. and S.T. students and the same provision may be considered to all the students of KGBVs as the girl students who are admitted into these schools are drop-out girls from B.C. and Minority families which are Below Poverty Line.

3. Government after careful examination of the matter hereby decided to exempt the payment of SSC Public Examination fee to all students appearing from KGBV Schools in the State.

4. This order issues with the concurrence of Finance (ESE) Department vide their U.O.No.29331/404/ESE/2007, dated 6.11.2007.
