ORDER

In the circumstances reported by the Director of Technical Education A.P.Hyd in the reference 5th read above Government after careful examination hereby issue the following amendment to the G.O.Ms. No. 207, HE (EC1) Dept, dated 28-06-1999.

AMENDMENT

2. For the existing para (4) after (iii) Incorporatingly in the G.O.Ms. No. 207 HE (EC1) Dept, dated 28-06-1999 the following shall be read as :-

4 (iv) The candidates selected for Pratibha awards from the academic year 2004-2005 onwards, shall be eligible for the sanction of scholarships only if their parents' annual income from all sources including income from non-taxable income like agriculture etc., does not exceed Rs. 1.00 lakh per annum. In case of salaried parents, their annual income should be less than Rs. 1.00 lakh per annum and they should also be non-taxpayers. The candidates seeking pratibha scholarships they have to submit latest annual income certificate of their parents issued by MRO concerned in case they are non-salaried and a copy of form 16 in case of salaried parents, issued by employer concerned.

(v) All the candidates selected for Pratibha awards however shall be given a certificate & medal.

3. This amendment shall be effective from the academic year 2004-2005. However, the candidates who have already been selected in the earlier years for award of these scholarships shall continue to draw the scholarship for the remaining duration of their study in terms of the earlier Govt Orders.
