PRATHIBHA - Sclience for promoting quality and excellence in Education, - Preparation of Merit list and selection of candidates - Certain norms issued by C&DSE - Ralification - Orders - Issued.

Government in the G.O., 1st referred above have issued orders sanctioning "PRATHIBHA". Scheme for Meritorious students who excel in Public Examinations/Entrance Test from Class VII onwards for award of Merit Certificates, Mementos and Scholarships. It was further decided to formulate specific norms for the selection of the candidates. Accordingly the Commissioner & Director of School Education in consultation with Secretary, School Education and Principal Secretary, Higher Education, has prescribed norms and communicated to "all District" Educational Officers pending formal approval and ratification of the same by the Government.

The following norms as prescribed by Commissioner & Director of School Education accordingly, are hereby ratified:-

(i) A common merit list of candidates indicating the Date of Birth, total marks obtained, community to which he she belongs, name of the school of the candidates should be prepared by each. District Educational Officer, for classes VII and X for the students studying in recognized schools only. (The information with regard to 7th Class is available with District Educational Officers and the information in respect of 10th Class was furnished to the District Educational Officers by the Office of the Director of Government Examinations.) 1.137

(ii) The students who have not studied in recognized schools are not be taken into consideration.

(iii) From the integrated merit list, the candidates who are toppers among STs (both Boys and Girls) are to be selected in the first instant. After selecting STs, similar procedure is to be followed for selecting the candidates for the categories of SCs, BCs, Minorities, P.H. candidates and OCs one after the other.

(iv) The O.C. calegory means 'Other Castes' (after excluding STs, SCs, BCs, Minorities, P.H. candidates) and not 'Open competition'. After the candidates in O.C. are selected, in order to select candidates for the Women quota the following procedure is to be followed. The girls who have been selected in any of the categories, listed in item (iii) will be oounted under the above categories only. From the remaining candidates in the merit list girls, who are meritorious regardless of caste or religion are to be selected.

(v) whenever there is a ne of marks among candidates in the same category the marks obtained by them in non-languages are to be taken into account to resolve the tie. The candidates belonging to linguistic minorities were not taken into consideration. Government hereby railfy the action of the Commissioner & Director of School Education in having communicated the above norms and in finalizing the specific candidates under the Schome Frathibha, under each Category for the VII Class and SSC Examinations.
